- ♣ Underused Housing Tax (UHT) The UHT imposes a national annual 1% tax on the ownership of vacant or underused housing in Canada that took effect on January 1, 2022. The tax usually applies to non-resident, non-Canadian owners. In some situations, however, it also applies to Canadian owners. Legal ownership of real estate must be considered as of December 31, 2022 and December 31, 2023, with filings and/ or taxes first being due on April 30, 2024. see the website for more details.
- Property flipping rule Starting January 1, 2023, any gain from the disposition of a housing unit (including a rental property) located in Canada, or a right to acquire a housing unit located in Canada, that you owned or held for less than 365 consecutive days before its disposition is deemed to be business income, however there are exemptions.
- Property Ownership If you are a co-owner of a property, you have to determine if a partnership exists or not.
